<u>Presentation by Sally Willson on April 4</u> "A Journey Back in Time"

Sally Willson inherited four suitcases stuffed with letters, diaries and documents representing multiple generations of her family. She then began her own journey of discovery. Who were these ancestors? What stories did they have to tell?

Sally will answer those questions as she recounts her family's history and domestic life in 18^{th} and 19^{th} century America in the Torch paper, "A Journey Back in Time," that she will present to the Columbus Torch Club on April 4. Club members Diane McKenzie, Bruce Smith and Otha Gilyard will participate in the presentation as they read excerpts from the letters and diaries.

"'A Journey Back in Time' will take us to 1700 and 1800 when travel was by tall ships, horseback, stage coach, canal barge and eventually railroad cars," Sally says. "First, we will join 300,000 Europeans to experience what it was like to sail across the Atlantic in the 1700s, unlike the 300,000 Africans who forcibly crossed in the same period." For Sally's ancestors, the destination was Philadelphia.

"Then we're going to travel by horseback over Indian trails, rivers and creeks in frontier Pennsylvania with two young missionaries, Yale graduate David McClure and Princeton graduate Philip Vickers Fithian. Next we will meet John Johnston, a young Scotch-Irish minister who immigrated to Pennsylvania in 1784. Unlike McClure and Fithian who returned home to the East Coast after their missions, Johnston settled permanently in Pennsylvania's remote western frontier and became the first regular pastor of two primitive log churches."

Sally explains that Rev. Johnston's story is based on letters dating from 1801 to 1889, plus diaries and photographs. She compiled his story over three years with multiple visits to archives at Princeton University Seminary, Huntingdon County Historical Society and Venango County Historical Society in Pennsylvania, Ohio History Center, Rare Books and Manuscripts Library at Ohio State University Libraries, Columbus Metropolitan Library, and Family Search Center in Reynoldsburg. She also visited

cemeteries in Huntingdon and Franklin, Penn. She received technical help and support to prepare her presentation from TV and video producer Amy Paulin.

From Johnston's story, "we will learn how unforeseen circumstances and Pennsylvania's remote distances created tragedy and challenge for generations to come," Sally says.

Member's Moment - Edgar Shaudys

Ed is a farm boy from Pennsylvania who has spent his adult life in Ohio. Ed came to Ohio to enroll in the liberal arts program at Wilmington College at a time when the college was engaged in setting up a college farm and a limited curriculum in agriculture. While Ed served as a laboratory assistant in the biological science courses, he also participated in the development and management of the college dairy herd and in the organization of the college's creamery and milk processing plant. It is not surprising that he was initiated into Delta Sigma Delta, the Agricultural Honorary Fraternity. More significantly, as a student, Ed met a young coed, Elizabeth Ann Townsend, who would become his wife. Today, they have four children, 11 grandchildren and three great-grandchildren. Recently, they celebrated their 66th wedding anniversary.

Based on his performance as an undergraduate, Ed was selected as a graduate student in the Department of Agricultural Economics and Rural Sociology at The Ohio State University. After receiving both his M.S. and his Ph.D., he accepted a joint position in the department and the Ohio Agricultural Research and Development Center. The result has been a highly successful career as a scholar and scientist. Most of Ed's more than 70 publications pertain to farm management problems in Ohio. They are all directed toward providing answers that are useful in practical decision-making. In addition to being useful for farmers and extension agents, the publications serve as useful classroom teaching aids.

Ed was recognized as an outstanding teacher. His case problem method of teaching farm management was popular with students who found it to be a unique learning experience. Students were presented with farm management problems. Working in groups, they were challenged to apply economic principles to see which group could arrive at the most feasible solution. The focal point of his courses was the analysis of actual commercial farm problems. The quality of his teaching was evident in the department nominating him for the Distinguished Undergraduate Teacher Award of the American Agricultural Economics Association. Ed has served several terms on the College of Agriculture's curriculum committee and was involved in the formation of the college core course, "A Study of Our Socio-Economic System," that may have benefited the faculty as much as the students.

Although Ed's interests have focused on farm management in Ohio, he did participate in a collaborative research program funded by the Midwest Universities Consortium for International Activities. He spent two summers in Somalia as a team member and chief of party.

Ed also has been active on several North Central States committees of the Farm Foundation. He has served as a member and chairman on committees dealing with farm management, commercial agriculture, agricultural productivity, land-use and taxation. He was college vice president of the

American Society of Farm Managers and Rural Appraisers and the executive secretary-treasurer of its Ohio chapter.

In addition, Ed was a board member at his alma mater, Wilmington College, for 11 years and its board chairman for three years. Locally, he has been a member of the Grandview Heights Library Board of Trustees for 30 years; a member and chairman of the Grandview Heights Board of Health; and a member of the Columbus Real Estate Board. Ed holds a real estate broker and salesman license. Also, he manages two farms as a landlord share operator and F.T. Shaudys Rentals, Ltd., for flats and townhouses.

On a personal note, Ed has a longtime hobby of restoring and showing classic cars, especially Oldsmobiles. He has restored about a dozen high-performance Oldsmobiles. He and Elizabeth have attended and participated in shows from Canada to Texas and from New York to California. They chaired the National Oldsmobile Club meet in Columbus at which 600 cars were shown and attended by more than 3,000 participants.
